

**TCC/Macedonia Baptist Iowa Test
Waiver of Liability Relating to Coronavirus / COVID-19
For Spring May 2024 Testing**

The novel coronavirus, COVID-19, has been declared to be a worldwide pandemic by the World Health Organization, and is reported to be extremely contagious. The state of medical knowledge is evolving, but the virus is believed to spread primarily by droplets in the air, by person-to-person contact, and possibly by contact with contaminated surfaces and objects. People reportedly can be infected and show no symptoms and therefore unknowingly spread the disease. Evidence has shown that COVID-19 can cause serious, potentially life-threatening illness and even death. The agents of Macedonia Baptist Church, the proctors, and the coordinators of this year's Iowa Test cannot prevent you or your child(ren) from becoming exposed to, contacting, or spreading COVID-19 while attending the Spring 2024 Iowa Test (either before, during, or after the Spring 2024 Iowa Test). Therefore, if you or your family members attend the Spring 2024 Iowa Test at Macedonia Baptist Church (located at 10481 NC-42, Holly Springs, NC), it is possible that you may expose yourself (and child(ren)) to and/or increase your risk of contracting or spreading COVID-19.

By signing this form, you acknowledge that you have read and understood the above warning concerning COVID-19. By signing this form, you accept the risk related to COVID-19 for yourself and your child(ren) accompanying you to Macedonia Baptist Church (whether or not they participate in taking the Iowa Test). The testing service at Macedonia Baptist Church is of such value to you and/or your child(ren) that you hereby choose to accept the risk of being exposed to, contracting, and/or spreading COVID-19.

By signing this form, you hereby forever release and waive your right to bring suit against Macedonia Baptist Church, its agents, or Iowa Test proctors and Test Coordinators (including the BJU Press Testing Company and its affiliates) in connection with your exposure, infection, and/or spread of COVID-19 resulting from you and your child(ren)'s participation in the Macedonia Spring 2024 Iowa Testing. You understand that this waiver means you give up your right to bring any claims, including for personal injuries, death, disease, property losses, or any other loss, including but not limited to claims of negligence and give up any claim you may have to seek damages, whether known or unknown, or foreseen.
